- The process of examining the return of income by the Income- Tax department is called as "Assessment".

PROCEDURE FOR FACELESS ASSESSMENT

1. Officer's request being made for assessment requests to file returns or notices, the request shall be assigned to the "Virtual processing Center" or a "Virtualized unit" through an automated allocation system.

2. Upon a request being made, pending technical assistance, an officer, the request shall be assigned to the "Virtualized unit" or a "Virtualized unit" in real time through a "Virtualized Center" through an automated allocation system.





3. The Virtualized processing Center will send the request & process, which the virtual officer will be assigned to for the concerned assessment unit.

4. In case a technical difficulty in the request, the Virtualized processing Center will send a request to the officer, who will be making a final judgment/assessment.



