- 2. Both parties recognize the mutual benefits of such collaboration in areas including, but not limited to the Board of Studies, guest lectures, mutual training programs, mentor mentee program and industry-academia connections.

#### NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

### 1. Objectives

- To associate to deliver Consulting opportunities in management and engineering.
- To collaborate on the development and enhancement of curriculum through the participation of TKAP experts in the Board of Studies.

- To foster industry-academia connection through an internship program to bridge the gap between theoretical learning and practical application.

# 2. Scope of Collaboration

# 2.1 Consulting project opportunities in management and engineering.

 TKAP and KSGI shall mutually explore and execute the consulting opportunity in Management and Engineering according to the requirements

#### 2.2 Board of Studies

TKAP will nominate subject matter experts to be part of the Board of Studies at KSGI.

#### 2.3 Guest Lectures

- TKAP will arrange guest lectures by its experts and professionals at KSGI on topics relevant to the curriculum and industry trends based on request.
- KSGI will schedule and organize these guest lectures to gain industry exposure to students
  & faculties.
- The KSGI's remuneration policy applies to such Guest Lecturing activities.

# 2.4 Mutual Training Programs

- TKAP will provide training programs for the KSGI's faculty and students on industryrelevant skills and technologies.
- Based on TKAP's needs, the KSGI will offer training programs for TKAP employees to enhance their knowledge in relevant disciplines.

• Both parties will jointly develop and conduct training sessions, workshops, and seminars as mutually agreed upon to the students of KSGI & employees of TKAP.

### 2.5 Industry-Academia Connect

- TKAP will offer internships and project opportunities for KSGI's students to gain handson experience under available internships at TKAP based on problem statement & Meritious selection. The stipend (if any, as decided by the TKAP) and the duration shall be mutually agreed upon.
- The KSGI will encourage students to participate in these internships and provide academic support for industry-driven projects.
- Regular meetings and interactions between TKAP professionals and KSGI faculty/students will be organized to exchange ideas and foster innovation.

### 3. Confidentiality

- Both parties agree to keep all information and data exchanged during collaboration confidential and not disclose any such information to third parties without the prior written consent of the other party. (including participating faculty & students)
- This obligation of confidentiality shall survive the termination of this MOU.
- The confidentiality obligation does not apply to publicly available information independently developed by the receiving party or required to be disclosed by law.

#### 4. Amendment Details

- This MOU may be amended only by mutual written consent of both parties.
- Any proposed amendments shall be discussed and agreed upon by both TKAP and KSGI, and shall be documented in writing.

 Amendments will become effective upon the date of the last signature of the representatives of both parties.

# 5. Duration, Termination and Renewal

- This MOU shall remain in effect for two (2) years from the date of signing.
- Either party may terminate this MOU by giving a 60-day written notice to the other party.
- Termination of this MOU shall not affect the completion of any ongoing projects or activities initiated under this MOU.
- This MOU will automatically renew for successive two-year periods unless either party provides written notice of intent not to renew at least 60 days before the end of the current term.

# 6. Cost and Funding

- The costs associated with the activities under this MOU shall be borne as mutually agreed by both parties.
- Any specific funding requirements for guest lectures, mutual training programs, and industry-academia connect initiatives will be discussed and agreed upon in writing by both parties before the commencement of such activities.

#### 7. General Provisions

- This MOU is not intended to create legally binding obligations between the parties.
- Both parties agree to act in good faith and in a spirit of cooperation to achieve the objectives outlined in this MOU.

- The Parties shall, in connection with this Agreement, comply with all applicable antibribery/corruption laws and regulations applicable to his business operations.
