#### **Payment of Tuition Fees**

Please refer to the Tuition Fee Payment Liability policy that was sent to you with your initial offer, as part of the 'Student Contract'. If you are a self-funded student, your tuition fees can be paid over two instalments, and your initial payment (due as part of online registration) will be 50% of the remaining balance after deducting any tuition fee deposit payment you have made.

#### **Information About Starting Your Course**

#### Information for Students Who Require a Student Visa to Study in the UK

If you need a Student visa to study in the UK, and we haven't yet been in contact with you, we will contact you from 6 months before the start of your course with a link to an online CAS questionnaire. You will need to complete this before we can issue your Confirmation of Acceptance for Studies (CAS). A CAS is issued after:

- we have received and reviewed your CAS questionnaire responses
- any other information and documents requested have been received and reviewed, and you have passed a credibility assessment where required
- any deposit has been paid (if needed)

You can track the progress of your CAS using the CAS tracker on your myEssex applicant portal.

Once your CAS has been issued, you will be able to access your CAS statement on your myEssex applicant portal.

If we find that you are unable to meet all Student visa requirements (including when there have been changes to those requirements made by the Home Office), we may not be able to issue you a CAS.

#### **Graduate Route Eligibility**

Students holding a Student visa who successfully complete a Masters or PhD course in the UK, and meet other relevant eligibility criteria, are able to apply for further immigration permission to remain in the UK for two or three years with a Graduate visa. If you are interested in applying after you finish your course, you'll need to meet all the Graduate route requirements, including studying in person in the UK from the start of your course. The scheme will only be open to those who have studied in the UK for a relevant period on a Student visa. If you start studying with another type of immigration permission, you may not be eligible. If you are interested in the Graduate route, see our website for more information and useful links.

#### **Arrival dates**

The course start date at the top of this letter is the date that teaching begins for your specific course. If we issue you a CAS to enable you to make a Student visa application, your CAS will include a start date that is different. The date in your CAS is the date that you should aim to arrive at the University in order to complete registration and take part in Welcome Week. If you are interested in the Graduate route after your studies, arriving by this date will also mean that you meet the 'length of study' criteria for eligibility to apply.

#### Cost of living

We understand the challenges our students, staff and applicants are facing during the current cost of living crisis. We believe in the value of community; in supporting people as best we can through difficult times. We have a number of measures to provide assistance for our students and staff.


